# **Occupational Health**

Hearing is just one of a number of health issues which needs careful consideration. Other risks include lung disease from welding fumes, painful and irritating skin problems such as dermatitis from chemicals and steel fragments and HAVS (white finger), which is a result of excessive vibration from the likes of hand tools such as drills



Over the last few years a rigorous Occupational Health Programme has been put in place to help protect employees at risk from such issues. The long-term health of employees is as important as their day-to-day safety. The Health surveillance programme includes regular monitoring and tests by qualified doctors and nurses to identify early any problems which might arise. However, prevention is always better than cure and one of the key means of preventing health and safety problems is by following the procedures as set out in the Risk Assessments and Method Statements.

Congratulations also go to the Isle of Sheppey Team who were Site Safety League winners in May 2012.



These range from handrails and trolleys to gates and now a growing amount of heavyduty equipment for the oil and gas industry



With around 140 factory workers and considering the size, versatility and nature of the work undertaken here, Health & Safety is obviously a top priority with strict controls and measures essential to the smooth running of the factory.

## **Equipment**

The Dundee factory boasts an impressive amount of equipment and machinery including presses, folders, welding equipment, plasma cutters, guillotines, forklifts and When operated correctly cranes. this equipment ensures we can produce and deliver quality products and services to our clients. However, many of these machines are also capable of delivering catastrophic results in seconds. Training is therefore essential in maintaining the safety of our employees. Only fully trained operatives are allowed to operate the equipment and a list of those is displayed on each machine. If your name is not on the list you are not, under any circumstances, permitted to operate the machine.



A full list of safety checks and instructions is also provided at the machine. If any of these are missing employees are asked to inform their supervisor/manager so they can be replaced immediately.




## **Employee Notice**

Hand and arm injuries are now the most common type of injury sustained whilst using sheet metal machinery, often caused by momentary distractions or lapse in concentration when operating these machines. It is therefore vitally important to follow training and stay focused on the job in hand. Remember, these machines are designed to cut and form steel. Flesh and bone DO NOT STAND A CHANCE



With centralization the Production to Dundee, the Company has recruited many new employees. It is therefore extremely important to be vigilant on training and supervision to ensure all are working safely. Most new employees will have either a Navy Blue or Red boiler suit.



Company requires responsible employees to assist in training, supervision and generally making the new employees feel part of the TEAM (Together Everyone Achieves More).

## PPE

PPE is issued to all employees for their own protection. A significant amount of time has gone into ensuring that the right equipment is available for each job. Glove specialists have assessed specific

tasks and areas within the factory to identify the best glove for the job. The results are displayed in a number of posters throughout the factory detailing the type of task and the most appropriate glove for the job.



Eye injuries were one of the most common factory injuries with 14 in 2008 alone. However with the introduction of mandatory eye protection, this fell to 2 in 2009 and has stayed at this level since. Posters are displayed showing the most appropriate goggles for each task. Prescription goggles are now also available and anyone who feels these would be helpful should speak to their supervisor.

## Noise

With all the machinery, the Dundee factory is inevitably a noisy place. Galloway Acoustics have measured noise levels throughout the factory and will continue to monitor this. Over time, exposure to this level of noise can have a detrimental effect on hearing. Unfortunately at present, there is no practical way of reducing the noise to safe levels within the factory and for this reason hearing protection within the factory is mandatory for all.



## Risk Assessments and Method Statements

With so many different activities taking place, each with a number of significant risks attached, it would be easy to overlook things. To make sure that every aspect is covered and that everybody is working to the same standard and safety procedures, a formal system of Risk Assessments and Method Statements have been produced. These cover all tasks, machines and operations.

### **Training**

Training plays an essential part in the safety of all employees. The equipment, tools and materials used in the factory can be dangerous not only to the person using them, but also to the people nearby. As well as training on the use of equipment, manufacturing procedures and skills such as welding or forklift operation, Galloway Group also has a range of Toolbox Talks covering various day to day topics including "Slips, Trips & Falls", "Vibration", "Manua. Handling" and "Waste Management". "Vibration", "Manual
